#### M RATED MOVIES - YEARS 7 to 10 only

Throughout the year students in years 7-10 may be required to watch M rated movies as part of their studies in subjects including literacy, health or SOSE. The movies chosen are at the discretion of the teacher and do not contain inappropriate language, explicit sex scenes or violence. They are, however, suggested adult themes. If you have any questions please contact your child's teacher. Students without consent will be given alternative work at another location.

#### **LOCAL EXCURSION**

Outings within walking distance of the school without cost form an ongoing part of the curriculum. To avoid unnecessary paperwork for both yourself and staff, this approval allows your child to attend all local excursions during the year. An example would be Ferny Creek Reserve.

## **HEAD LICE**

Authorised staff by the school principal may visually check your child's hair for the presence of head lice, when it is suspected that head lice may be present. Prior to any inspection, the student will be advised of the reason why they are being checked and the procedure to be carried out. If head lice/eggs are found, parent/guardians will be notified. Please note, due to the sensitive nature all checks are carried out in private.

## **PHOTOGRAPHY & FILMING OPT IN/OUT**

During the school year there are many occasions and events where staff may photograph, film or record students participating in school activities and events.
